I am by direction to inform you that applications for starting of new courses (Except Research Programmes) from the academic year 2012-2013 in the colleges are invited by the University and the same shall be submitted to the Registrar, Bharathiar University, Coimbatore 641046 (in the prescribed proforma), **on or before 31.10.2011 without the efflux of time.** The applications received after the last date shall be rejected. The Colleges are advised to complete all the formalities well before the start of the admission process.

The list of courses offered during the academic year 2011-2012 is enclosed.

Further, it is informed that the proposals should be forwarded along with a copy of the **full signed minutes of the College Committee** meeting stating that it has been resolved to start the new course(s) for the academic year 2012-2013, failing which the applications are liable to be rejected.

A crossed Demand Draft for **Rs.1,000/- per course towards Registration fee, Rs.10,000/- per Course (UG/PG) and Rs.5,000/-per Certificate/Diploma/PG Diploma course** towards application fee to be drawn in favour of the **Registrar, Bharathiar University, Coimbatore 46** and the same shall be enclosed along with the application. Applications received without the Registration fee and Application fee will be rejected and no further communication will be entertained in this regard.

The college shall create all necessary infrastructural facilities like laboratory, library, class rooms, and appointment of teaching and non-teaching staff for starting of new courses at the time of submitting applications. This will facilitate the University in constituting inspection commission for granting affiliation and will avoid any delay in granting the required affiliation. While applying for new courses, colleges have to necessarily give an undertaking that they have already provided the necessary infrastructural facilities for the existing courses.

As per the schedule, the inspection Commissions shall be visiting the colleges between January and March 2012. In case, the Commission observes and reports lack of certain requirements, the college has to fulfill the requirement(s) and send a compliance report on or before 15<sup>th</sup> May 2012. The entire process of granting affiliation is scheduled to be over by 10<sup>th</sup> of June 2012 which will be followed strictly. Non-compliance at any stage will result in the college being placed in the "No admission" category.
