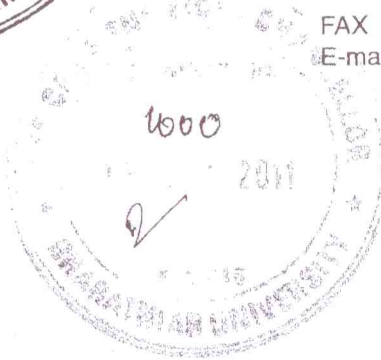

Dear Sir/Madam,

As you are aware the Unique Identification Authority of India, Government of India has decided to provide a unique identification number called "Aadhar" to each resident of the country, which would be the basis for efficient delivery of welfare services. Canara Bank is preparing to set up Aadhar Enrolment-cum-Savings Bank Account Opening Counters in universities and colleges in the country to link Aadhar with students' bank account numbers. No cost will be charged by the bank from the institutions or students.

Linking of Aadhar to students' bank accounts would facilitate effective delivery of central schemes viz. loans to eligible bonafide students, help track students to minimize the possibility of defaults on loans and encourage more banks to be a part of the central schemes besides disbursements of scholarships and fellowships.

It is requested that your university and colleges affiliated to it cooperate with Canara Bank in setting up the enrolment counters.
